PUBLIC CONSULTATION

Mental Health Commission: Quality Framework for Mental Health Services - Consultation on Draft

The Mental Health Commission published the Quality Framework for Mental Health Services in Ireland in March 2007. The themes, standards and criteria contained in the quality framework provide clear guidance for service users, their families/chosen advocates, service providers and the public as to what to expect from a mental health service. The quality framework is applicable to all mental health services including services for children and adolescents, adults, older persons, persons with an intellectual disability and a mental illness and forensic mental health services. The quality framework comprises of eight themes, 24 standards and 163 criteria. The framework places the service user at the centre. To assist in measuring attainment of standards and associated criteria, a draft toolkit has been developed to accompany the framework. The Mental Health Commission is seeking views on the draft audit toolkit and would welcome your comments and feedback on the draft document using the consultation form on their website — www.mhcirl.ie - by 15th June 2007. HEALTH BILL 2006

The Health Bill 2006, which was published in December 2006, is currently before the Oireachtas. The Bill establishes the Health Information and Quality Authority (HIQA), incorporating the Office of the Chief Inspector of Social Services, on a statutory basis. HIQA will set standards on safety and quality for all services provided by the HSE and service providers on behalf of the HSE, including residential services for people with disabilities and nursing homes. It will also provide an independent review of quality and performance and its analysis will inform policy development within the Department. It will monitor compliance with the standards it sets and advise the Minister and the HSE on the level of compliance.

HEALTH & SOCIAL CARE PROFESSIONALS ACT 2005

This Act provides for the establishment of a system of statutory registration for certain health & social care professionals. This will help to ensure that members of the public are guided, protected and informed, so that they can be confident that health and social care professionals providing services are properly qualified and competent to practice. The regulatory system will aim to ensure professional conduct and the maintenance of

high standards of professional education and training among health and social care professionals. At the launch of the Health & Social Care Professionals Council by the Department of Health & Children on 26th March, 2007, we welcomed the announcement that Mr. Tony Darmody, Chief Executive, Kerry Parents & Friends Association, will represent the National Federation of Voluntary Bodies on

'Managing for the Future - Building your Skills as a Front Line Manager in a Person Centred Environment' - Pilot Programme

entitled 'Managing for the Future — Building your Skills as a Front Line Manager in a Person Centred Environment' participants were sought for the pilot of the Programme which commenced in February 2007. There are 21 participants, from 14 organisations, currently engaged in the pilot which is being run in the University of Limerick.

Following the launch of the programme materials for the programme The Programme is due to be completed in October 2007. There are a number of trainers 'shadowing' the training as they will be subsequently seeking to roll-out the training programme within their own organisation. The training is being delivered by The Performance Partnership in conjunction with personnel from the Kemmy Business School, University of Limerick.

'Managing People - Management Development Programme'

The seventh and final 'Managing People -Managing People Programme' being run by the National Federation of Voluntary Bodies is now completed. The training was delivered by the Open Training College. Over 140 personnel from across National Federation of Voluntary Bodies member organisations have completed the 3-day programme which seeks to enhance managers' understanding of competency frameworks and particularly to develop their competencies in the area of 'Managing People'. Specifically the programme aims to ensure that managers are familiar with the process, materials and resources involved in the management competency frameworks and focus on skills training in the following 'Managing People' competencies: Supporting Personal Development; Creating Team Spirit;

Being the communication channel; Managing Individual Performance; Influencing people & events. An event to mark the conclusion of this series of programmes is being organised at which a presentation of Certificates will be made to those who have completed the programme and successfully secured accreditation from the Open Training College.

SKILL PROJECT - QUOTA ALLOCATION 2007/8

A series of briefing sessions in relation to the training available under the SKILL Project have been running over the period January-March 2007. The quota allocation of training places under the SKILL Project for the intellectual disability sector for 2007-2008 is 435 for Support Service Staff with 15 places being allocated to Support Service Managers. The objectives of the SKILL Project for support staff and support service managers are to:

- Provide an opportunity to return to learning;
- · Update and extend knowledge, skills and to improve job efficiency and effectiveness, and consequently improve services to patients / clients;
- Enhance satisfaction and motivation in order to contribute more fully to the attainment of the organisational mission;
- Develop areas of expertise to progress the "skill mix" requirements of the health services having regard to workforce and succession planning issues
- Assist in reaching full potential;

INO/PNA INDUSTRIAL ACTION

A National Steering Committee has been convened by the HSE — Employers Agency with the aim of ensuring a co-ordinated response at a national level to the industrial action being undertaken by the INO/PNA. The National Federation is represented on this National Steering Committee by John Pepper, St. John of God Hospitaller Services, Gerry Mulholland, Stewarts Hospital and Sean Abbot, COPE Foundation. A number of Regional Committees have also been established which include representation from all relevant stakeholders including the National Federation. A briefing session in relation to the dispute was held in Stewarts Hospital on February 21st 2007 at which John Pepper provided an update on the key issues involved. The National Federation of Voluntary Bodies will be seeking to ensure that there is an effective communication structure in place that allows for the timely flow of information.

LONG STAY CHARGES

A Working Group has been established to look at member organisations issues with regard to the implementation of the above charges, under the chair of Mr. Wally Freyne, Director of Services, Daughters of Charity Services. Following a recommendation from the Working Group, a letter has issued to Ms. Mary Harney, T.D., Minister for Health & Children, requesting a meeting with her to discuss the application of the current legislation on the intellectual disability sector and the need for either new legislation or an amendment to the current legislation to make it more applicable and equitable to our sector. The Working Group has also outlined a number of recommendations which are currently being addressed.

Disability Act 2005

The Disability Act 2005 takes legislative effect in respect of 0-5 year olds from 1st June, 2007 The National Federation of Voluntary Bodies in a letter dated 15th March, 2007, to Professor Brendan Drumm, Chief Executive, HSE, expressed its serious concerns at the absence of an agreed working document to convert policy into practice. A document prepared by the Federation's Early Intervention Expert Working Group, which was established by our Education Sub Committee, was submitted to the HSE and we await engagement with us in relation to this document by the HSE.

CITIZENS INFORMATION ACT 2007

The Citizens Information Act 2007 was passed into law in February 2007. The primary purpose of the Act is to amend the Comhairle Act 2000. The Act provides for the change of the name of Comhairle to the Citizens Information Board. Most importantly, the Act provides for the introduction of a personal advocacy service for certain people with disabilities who would otherwise have difficulty obtaining access to the services in place to assist them.

LEGISLATION

Charities Legislation

The General Scheme for the Charities Regulation Bill was published in March 2006. The General Scheme forms the basis for legislative drafting of the Charities Bill, which will provide a modern statutory framework for charities. It is not now expected that this legislation, which is currently being drafted, will be enacted before the General Election. An update on the Charities Legislation was presented at the National Federation General Assembly Meeting on Wednesday 21st March 2007.

Informing Families Project

The National Federation of Voluntary Bodies, with the support of the Health Services National Partnership Forum, has initiated a project to develop and implement national best practice guidelines for informing families that their child has a disability. This is a Department of Health & Children and HSE supported

The project aims to develop National Best Practice Guidelines for informing families of their child's disability at the first stage of communicating a diagnosis or concern, and to recommend education and training for staff involved in informing families. The guidelines are being developed through research involving hospital, community care and disability services; management and staff; and families of children with disabilities. The research is guided by a steering committee, chaired by Dr. John Hillery, President of the Medical Council of Ireland & Consultant Psychiatrist with intellectual disability services, Stewarts Hospital and St. Raphael's (St. John of God Services), with representation from key groupings such as parents, professionals bodies and unions, the HSE, the Health Services National Partnership Forum, the Department of Health & Children and the National Federation of Voluntary Bodies.

Twenty two focus groups have been completed and 2,200 questionnaires have been circulated to parents and professionals. These are currently being analysed and collated, and together with a comprehensive review of international best practice, will form draft best practice guidelines, which will then undergo a process of consultation with key stakeholders, followed by a comprehensive dissemination and implementation strategy

UN CONVENTION

The full text of the UN Convention on the Rights of Persons with Disabilities, including the Optional Protocol is available at http://www.un.org/esa/socdev/enable. The Convention was open for signature on March 30, 2007. There are 192 member states in the UN and 20 ratifications are needed for the treaty to become international law. The Tanaiste and Minister for Justice, Equality and Law Reform, Mr. Michael McDowell, T.D., announced on 28th March 2007 that the Government has agreed to his proposal that Ireland should sign the UN Convention.
