Development of New Services for People with Intellectual Disability Seriously Threatened in 2008

he uncertainty over the allocation of €50m which had been ring fenced in budget 2008 for the development of new services for people with disabilities was the cause of much anxiety over the past few months. The National Federation of Voluntary Bodies joined with the Disability Federation of Ireland and the Not for Profit Business Association in highlighting our serious concerns on this matter and the Federation mobilised all of our member organisations to highlight these concerns and bring to the attention of all elected TDs country around the the consequences of inaction on this issue.

It will be recalled that this funding is an important part of the Government's National Disability Strategy and is designed to go some way to addressing the significant unmet needs of people with disabilities and their families throughout the country. The National Federation of Voluntary Bodies was seriously concerned that this funding would be reallocated to offset deficits in other areas of the HSE, in effect meaning that people with disabilities would pay a heavy price for over-runs in these areas.

Thankfully following on from our campaign an announcement was made in early July 2008 by Mr John Maloney T.D., Minister of State for Disability and Mental Health that the 50m announced in Budget 2008 in respect of disability services will be used for this and no other purpose in 2008 and arrangements will be made by the HSE and service providers to put in place the required new services and supports as a matter of urgency. This announcement came as a great relief to all concerned in the disability sector, not least people with disabilities themselves and their families who had expectations that their needs would be met following publication by Government of the National Disability Strategy.

This relief is however tempered somewhat by the realisation that the funding announced by the Government to address the unmet needs of people with disabilities was under threat in 2008 and all concerned in the sector will be vigilant to ensure that no similar threat arises in 2009 and in future years.

STRUCTURE OF FEDERATION

Following the Consultation Day for Member Organisations held on 7th May, 2008, in the Heritage Hotel, Portlaoise, the National Federation's Strategic / Structural Working Group met on 28th May, 2008, to consider the workshop outcomes which looked at four different proposals with regard to how the Board should be nominated. At the meeting of the Board on 4th of June 2008, it was decided to accept the recommendation of the working group to place the current 5 interim Area Federation Committees on a permanent footing. In regard to the nomination of the Federation's Board of Directors, the Working Group recommended the following nuanced version:

Dublin North East	= Elect 2 Board Members
Dublin Mid Leinster	= Elect 2 Board Members
West	= Elect 2 Board Members
South	= Elect 2 Board Members
South Eastern	= Elect 2 Board Members
Total:	= 10 Elected Board Members
Co-option	= 5 Board Members
TOTAL:	15 Board Members

The Elected Board Members will make the co-options, however, one must come from each of the following geographical areas: Dublin North East; Dublin Mid Leinster and Western Region. The final 2 co-options to be made without any regard to geographic areas.

The above adaptation offsets to some degree the overrepresentations from the South and South Eastern areas. It also allows for some re-balancing in favour of the larger population areas. The co-options will be done by the elected Board, mindful of the design features we are seeking to incorporate within the full board.

The function of Board Members, particularly in respect of Area nominated representatives, is to represent the concerns of their Area Federation and not their individual organisation. The revised Memorandum & Articles of Association will contain explicit provision for the removal of Board Members by their nominating Area Committee, where that Area feels the elected Board Member is not representing their issues.

No member organisation will have more than one Board Member, other than in exceptional circumstances on the Board of Directors. This understanding will be an informal element within the overall framework of Board elections, rather than something which will be explicitly cited within the Memorandum & Articles of Association. Where the electoral situation breaches this understanding, the matter will be referred to the member organisation for resolution.

Larger service providers shall be able to nominate up to a maximum of three representatives to attend and participate at meetings of the Area Federations to which they provide services. Where agencies wish to invoke this provision, application will be made by the agency to the Board rather than to the Area Committee. However, the member organisation will have only one vote in respect of nominating an area representative to the Board.

Legal advice is currently being obtained to give effect to the above recommendations and the necessary changes to the Federation's Memorandum & Articles of Association are being made. It was noted that other areas to be considered included the term of office for Board Members and ensuring that all Board Members were not replaced at the one time and also the provision for appointing external representatives.



National Federation to Launch Six-year Research Strategy in August '08

The National Federation Research Strategy has been approved by the Board and will be published in August 2008.

The objective of this Research Strategy is to set out a vision for the research activities of the National Federation of Voluntary Bodies for the next six years (2008-2013). To provide high quality services to people with intellectual disabilities the field of intellectual disability must have a foundation of high quality research. The National Federation of Voluntary Bodies is committed to the dissemination of knowledge and the promotion of world class research. This strategy aims to develop a positive environment of discovery and learning which will help people with intellectual disabilities, their families, the wider community, service managers, front-line staff, policy makers and researchers determine what is good practice.

The strategy was developed through a series of consultations with member organisations. The Research Draft will be available to download and in hard copy from August 2008.

Commission on Nursing – Call for Submissions:

The Commission on Nursing was established as a result of a recommendation of the National Implementation Body (NIB) to produce an independent assessment of how a 35 hour week for nurses can be The Commission, which is achieved. chaired by Professor Tom Collins, began its work in March, 2008 and plans to submit its report by the end of December 2008. The Commission recently issued an invitation to all interested parties to submit their views on the type of flexibilities and changes which would be necessary in order to achieve a 35-hour week for nurses. In particular the Commission is seeking views on the following:

Changes / innovations to the role and scope of nurses in order to achieve a 35-hour week;

Changes required in the structure and organisation of a workplace in order to support the delivery of a 35-hour week;

System-wide changes required to improve service delivery and optimise patient care. Written responses by individuals, groups or organisations should be emailed to: submissions@health.gov.ie by Friday,August 29th '08.

GARDA VETTING

INTERNATIONAL:

An invitation was received from the Garda Central Vetting Unit to join a Working Group being established to consider the issue of securing garda vetting for international personnel seeking to work / volunteer in Ireland. In preparation for this meeting a brief survey was undertaken with National Federation members seeking to determine the number of people for whom international vetting is required, what countries personnel are coming from and the issues in terms of trying to obtain vetting. The meeting was very productive in terms of identifying the issues involved and it was agreed that the priority in the short-term would be to ensure that vetting arrangements are in place for persons traveling from Great Britain who are now seeking to work / volunteer in Ireland. The next step will be to consider Vetting at the European level. The challenges involved in securing vetting at an international level were discussed and this is a long term project that will require considerable liaison with the Garda Vetting Units counterparts in other countries.

HIQA National Quality Standards in Residential Services for People with Disabilities

Following extensive work by the National Standards Advisory Group supported by HIQA Executive Team over the past twelve months a draft set of quality standards in Residential Services for people with disability is now ready for consultation. The draft standards are currently with the national disability groups for feedback by the end of July 2008 and will be open to public consultation in September 2008. Following the public consultation, which will be completed by the end of October 2008, the final meeting of the National Standards Advisory Group on November 17th 2008 will sign off on the draft which will then be presented to the board of HIQA in December 2008. It is expected that the final document will be prepared and sent for publication in late January/early February 2009.

The National Federation of Voluntary Bodies Quality Sub-Committee has acted as a reference group in the development of the standards and is currently involved in the feedback process. Mr. Brian O' Donnell represents the Federation on the National Standards Advisory Group.

UN Convention on the Rights of Persons with Disabilities

The UN Convention on the Rights of Persons with Disabilities and its Optional Protocol entered into force on 3 May 2008, one month after the required 20th country ratified the treaty which guarantees rights of some 650 million people worldwide. This marks a major milestone in the effort to ensure equal enjoyment of all human rights and fundamental freedoms of persons with disabilities. As of July 2008 there are:

30 ratifications of the Convention and 18 ratifications of the Optional Protocol.

Currently, there are 130 signatories to the Convention and 71 signatories to the Optional Protocol.

"Convention on the Rights of Persons with Disabilities: Dignity and justice for all of us" is the theme of this years International Day for Persons with Disabilities – 3 December 2008 - as well as for the 60th anniversary of the Universal Declaration of Human Rights

On 27 March 2008, the Human Rights Council adopted a resolution on "The Human Rights of Persons with Disabilities," which "requested the Office of the High Commissioner for Human Rights (OHCHR) to prepare a thematic study to enhance awareness and understanding of the Convention on the Rights of Persons with Disabilities, focusing on legal measures key for the ratification and effective implementation of the Convention, such as those relating to equality and non-discrimination". In June 2008, "OHCHR will commence an open consultation with States, civil society organizations, intergovernmental organizations and national human rights institutions on the study."

HSE National Integration

In order to achieve a more integrated health and social care system the HSE is currently introducing some modifications to the way it is organised. The modifications which are designed to speed up the integration of primary, community and acute care and the HSE's transformation programme are as follows:

- A National Director of Clinical Care & Quality, with overall responsibility for clinical governance, quality and risk, will be appointed.
- (2) The two national service delivery positions (NHO and PCCC) will be integrated under the direction of a single National Director of Integrated Service Delivery.
- (3) There will be a new National Director of Planning.

- (4) Care Group roles at national level will provide a link with the Department of Health & Children to translate policy into operational standards and objectives to be delivered at area level.
- (5) Current Population Health functions will be reassigned to the directorates described under I-3 above as appropriate.
- (6) A new National Director of Communications will be appointed.

The modifications will be introduced during the remainder of 2008 and 2009 and will be overseen by an Implementation Team under the direction of the National Director of Human Resources.

Promoting National Federation of Voluntary Bodies as a 'Model of Efficiency'

The National Federation of Voluntary Bodies promotes the value and importance of the voluntary sector in the delivery of supports and services to people with Intellectual Disability in Ireland. In doing this the Federation recognises the necessity to continuously demonstrate the value-add which the sector brings in terms of enhancing the quality of life of the people we support.

In this regard the Board of the National Federation of Voluntary Bodies, at its most recent meeting, decided to establish a working group to assess, in consultation with all members, how our sector, people with intellectual disability and the tax payer are best served within the current resource availability. In general terms the group will be considering a number of steps to promote the National Federation of Voluntary Bodies as a model of efficiency in the application of public funds and to ensure that the allocation of resources to direct frontline support is optimised. A full terms of reference has been developed and is available from the Secretariat.

Open Training College gains HETAC approval for **2 new management COURSES:**

The Open Training College, the distance learning educational body established by St Michael's House in 1992, is pleased to announce HETAC approval for two additional Management Courses at the College. The accredited Courses are aimed at employees with management and supervisory responsibilities working in organisations in the non-profit sector.

The College will roll out a one-year Higher Certificate in Applied Management in autumn 2008 and a one-year Bachelor of Arts in Applied Management in autumn 2009. The College has already rolled out a Certificate in one-year Applied Management. The full three-year degree course will combine three individual oneyear management courses, which offer students accredited gualifications at the end of each year. Plans are afoot in relation to the future roll-out of the 'Managing for the Future: Building your Skills as a Front Line Manager in a Person Centred Environment' training programme and it is envisaged that a number of additional programmes will commence in autumn 2008. The primary aim of the programme is to enhance the capacity of front line managers in intellectual disability services to effectively carry out their role and to contribute to the human resource function within their organisation in partnership with key stakeholders. Specifically the Programme aims:

- To enhance and clarify learners (a) understanding of their role as a front line manager.
- To develop a specific set of skills and (b) competencies required by front line

Review Session – Bereavement Training Programme for Clinicians:

A review session for Clinicians that took part in the 3-day Bereavement Training Programme that was held in 2007 took place on May 29th 2008.
