Reading Materials and Resources on Advocacy

The following is a list of reading materials and resources on the subject of advocacy.

There has been very little published on advocacy in Ireland so far but The Citizens Information Board (CIB) have several excellent publications.

The Jigsaw of Advocacy – **A Research Report** prepared for The Citizens Information Board by John Weafer and edited by Mairde Woods. Published in September 2003.

This report describes models of advocacy in Ireland and abroad, explains their differences and proposes future options for advocacy in Ireland. It also looks at the role of CIB in developing advocacy services.

Developing An Advocacy Service for People with Disabilities Volume 1 by Goodbody Economic Consultants, published in July 2004. This study examines how CIB can develop and deliver advocacy services in Ireland, embracing best practice.

The report looks at advocacy models in England, Wales, Scotland, Australia, New Zealand, USA and Canada. The report was written in consultation with voluntary and community organizations working with people with disabilities. It sets out the three strands of advocacy to be delivered by CIB – The Community Visitors Programme, The Community and Voluntary Sector Programme and The Personal Advocacy Service.

CIB's quarterly report **Speaking Up For Advocacy** provides regular updates on the development of advocacy services around the country.

Advocacy Skills for Health and Social Care Professionals by Neil Bateman. (2000) This book is for professionals who undertake advocacy as part of their work. It gives advice on how to become a more effective advocate, using advocacy principles to best effect.
