# New Era for Intellectual Disability Sector

There has probably rarely been a more exciting, if somewhat challenging, time for people with disabilities, their families, the services who support them and the policy makers. As I write we have a new Government elected who will, as part of their new Programme for Government, have regard to the National Disability Strategy and the Value for Money & Policy Review and other important national policy initiatives. A key catalyst for the progression of change in the lives of people with disabilities and the organisations supporting them has been the adoption of the UN Convention on the Rights of Persons with Disabilities. Clearly major changes in how services and supports are configured and delivered will become an immediate priority.

The National Federation of Voluntary Bodies has been reflecting on how best to meet the challenges inherent in these important developments. The Board and member organisations of the National Federation have explicitly stated that they are up for the challenges presented which they will address in a proactive and constructive fashion.

However, as we embark on this very important next phase in the evolution of the intellectual disability sector in Ireland, we do so in the knowledge that we will not be accompanied on our journey by some very important people who have played a key role in the development of the sector both in terms of services and policy over the past number of decades. The National Federation of Voluntary Bodies acknowledges the critical roles played by Mr. Paul Ledwidge, Chief Executive, St. Michael's House; Ms. Maura Nash, Chief Executive, COPE Foundation; Ms. Marian Keigher, Chief Executive, Brothers of Charity Roscommon, all of whom have recently announced their decision to retire. In so doing, they join Mr. John O'Dea, former Executive Director, Western Care Association, and Mr. Michael Noone, former Managing Director, Sunbeam House Services, Bray who retired from their positions in 2010. All are people of the highest calibre who made huge contributions, not just to the development of their own organisations but, also at the national level by ensuring that the full extent of the unmet needs of persons with intellectual disability was understood by Government and through their advocacy by having those needs substantially met. They will be missed, but their professionalism, dedication, commitment and pioneering efforts will act as a formidable example as we brace ourselves to meet the many challenges ahead. We should

also acknowledge at this time the outstanding contribution made by Mr. John Moloney, T.D., during his term as Minister for Disability & Mental Health. During very difficult times his strident advocacy on behalf of people with disabilities at the cabinet table meant that disability services were protected from the worst of the funding cuts and his efforts in this regard are appreciated by all in the Disability Sector.

As already stated, disability supports are on the cusp of the most significant change and reform. Developments in national and international policy are significantly converging at the present time, identifying an urgent need to radically change the ways in which people with disabilities are supported to live ordinary lives of their choosing, as citizens and valued members of their communities. This creates many challenges, but also opportunities to do things differently and more effectively. Services will increasingly be based on choice and focussed on inclusion, ensuring that ordinary life experiences are available to people with intellectual disabilities who will have more control in the decision making processes relating to matters affecting their lives. This will be achieved through a reconfiguration of current service delivery models, including the individualisation of supports which will be enabled by individualised funding mechanisms, including a facilitation of self directed services.

The summary of key proposals from the Review of Disability Policy (Department of Health & Children 2010) recently published by the Department of Health & Children, indicates that the current model of services provision will be unsustainable and thus requires innovative reform. In this regard, the National Federation of Voluntary Bodies believes that civil society will play a more active role in shaping change and addressing needs. There will be increased and urgent emphasis on the development of more integrated approaches, greater dialogue and consultation between Governmental and non-Governmental organisations and greater transparency and accountability on the part of all the actors in terms of their activities, priorities and outcomes. The National Federation of Voluntary Bodies will develop an out-reach programme to partner with existing community groups at a national level in order to leverage the potential in natural supports for people with intellectual disability at every level of community life; sporting; recreation; citizenship; youth organisations and more. The aim of the programme will be to animate national connections in order to develop capacity for inclusion and belonging of people with intellectual disability within each of these organisations and to mobilise the national potential in each for stimulating social inclusion.

This is just one example of what different will look like. Clearly the challenge as we look to the future will be to ensure that the services and supports are sustainable, relevant and bring a measurable value add to the quality of people's lives. The National Federation of Voluntary Bodies is committed to working closely with the people we support and their families, Government and our funders to ensure that this challenge is met in a proactive and enthusiastic way.

## Launch of Going to College Project



An inclusive higher education initiative to support the civic engagement of persons with intellectual disabilities at NUI Galway

The Launch of the Going to College Project took place on Monday 17<sup>th</sup> January 2011 in NUI Galway. Conor Pope who is a TV presenter and Irish Times journalist & former student of NUI Galway welcomed everyone and introduced the speakers.

The Going to College Project is a university/community partnership between the UNESCO Child & Family Research Centre, NUI Galway; the Community Knowledge Initiative, NUI Galway and the National Federation of Voluntary Bodies. This project will enhance the opportunity for students to develop the vision, knowledge and transferable skills to live a more inclusive, independent life in their community.

Students will participate in classes and other learning activities alongside undergraduate students and will also have an opportunity to participate in a number of existing NUI Galway community and civic engagement offerings, including:

- volunteering through the ALIVE programme,
- involvement in community activities/projects,
- active engagement in university clubs and societies
- work placements linked with their area of study

The first speaker was Pat Dolan UNESCO Chair of Children, Youth & Civic Engagement. He spoke about how the launch of the Going to College Project would be the beginning of a Process of inclusion of people with intellectual disabilities in third level education in NUI Galway. He also said how this was a big step for NUI Galway and that he was happy to be involved in the process. He talked about how important it was for everyone to have a chance to learn and

to make friends and get involved in college life. He also said that this was a good example of a university/community partnership that worked well together to support students going to college.

The next speaker was Breda Casey who is working with NUI Galway to co-ordinate the Going to College Project. She spoke about how the students would start college in NUI Galway in September

2011 and each student would be individually supported while in college. She also said that they would be included in all aspects of college life both social and academic and they would have an opportunity to do some volunteering and work placements and join college clubs and societies. She said they would start recruiting students in March 2011.

The next speaker was Brian O'Donnell, CEO of the National Federation of Voluntary Bodies. He spoke a little about the National Federation's members and how they have a presence in nearly every town in Ireland. He said that the National Federation was delighted to be a partner in such a positive project and that it would give students an opportunity to learn skills that would help them to choose the life they wanted to live.

Then there was a panel discussion around the importance of people with intellectual disabilities having the opportunity to attend third level and what support could be given to them. The panel included:

- Coordinator & Academic Staff Developer of the Community Knowledge Initiative, NUI Galway (Lorraine McIIrath)
- Two people involved in business and who have agreed to act as employer champions for the project (Tina Roche from Business in the Community and Padraig O'Ceidigh from Aer Arann)

After the panel discussion there was a keynote address by Bruce Uditsky & E. Anne Hughson from the Alberta Association of Community Living & University of Calgary, Alberta Canada. They spoke about how they have been supporting people with disabilities going to college in Alberta for over twenty years. They also showed a short DVD presentation on the project in Canada which showed people with disabilities taking part fully in every aspect of university life in Canada. It also shows that both the students and the college benefited from the experience.

After that the going to college project was officially launched by Professor Nollaig Mac Congail Registrar & Deputy President of NUI Galway who said that NUI Galway was very committed to including students with intellectual disabilities in all aspects of college life.

Bruce Uditsky, Chief Executive of the Alberta Association for Community Living (AACL) and a parent and also E. Anne Hughson, Director/Associate Professor, Community Rehabilitation & Disability Studies, University of Calgary

were keynote speakers. Bruce and Anne facilitate the AACL annual Leadership Series for families in Alberta which has gained national and international recognition. The Albertan experience was accompanied by examples from across Ireland of families and services who have embarked on the journey of working together to support people with an intellectual disability lead inclusive and fulfilling lives. Peggy Ryan (Parent) and Sean Conneally (Director of East Galway Adult Services Brothers of Charity Services Galway) gave a presentation entitled "A Family's Reflections on Working in Partnership with a Service Provider". A project in Ability West was represented by Colette Daly, Brega Kelly, and Carol Ann Beegan and examined the topic of Family Empowerment. Where to Start? Martina Rynne from the Brothers of Charity Services Clare spoke about her experiences and learning form Mamre in Australia and how she brought these principles of working back to Clare Family Leadership - What? Why? How?. Leap - Families working in Partnership were represented by Rachel Cassen and Geraldine Graydon. LEAP stands for Leading - Showing and leading the way, Educating - Families, Professionals, Service Providers & Policymakers, Advocating resource allocation system and system and policy change and Planning - for better futures for people with Intellectual Disabilities and for people with Autism Spectrum Disorder and their families. There was also a presentation from Prof. Pat Dolan UNESCO Chair and Director of Child and Family Research Centre Galway.

# National Co-ordinating Group on Progressing Disability Services for Children & Young People

The National Co-ordinating Group on Progressing Disability Services for Children & Young People was convened by the HSE and is chaired by Ms. Breda Crehan-Roche, Chief Executive, Ability West. The National Federation of Voluntary Bodies is represented on the group by Ms. Maria Walls, Director of Research & Policy Development, National Federation of Voluntary Bodies Secretariat. To ensure that the breadth of National Federation's views is represented in this process of the

development of Children's Disability Services, we have agreed to establish a National Federation of Voluntary Bodies' Progressing Disability Services for Children & Young People Reference Group.

Nominations were sought from Member Organisations to participate in the Reference Group. The key aim of this Reference Group is to provide a conduit for information sharing and consultation between National Federation member organisations and our representative on the National Coordinating Group. The inaugural meeting of this group took place on Tuesday, 8th March, 2011..

National Federation Hosts Seminar entitled 'Advocacy in Ireland: Changing Times'

The National Federation of Voluntary Bodies held a seminar entitled: **Advocacy in Ireland: Changing Times** in Dublin on Wednesday, 9th February, 2011. The purpose of this seminar was to inform our members about the new National Advocacy Service which was established in January this year. The National Advocacy Service fulfils the legislative promise as set out in Comhairle Act 2000 and the Citizens Information Act 2007 to provide independent, representative advocacy services for people with disabilities. It will be managed by five Citizens Information Services and supported by the Citizens Information Board and will take over the work of the 46 pilot advocacy projects, with a particular remit for more vulnerable people with disabilities. The new Service follows many of the recommendations of the Evaluation of the Programme of Advocacy Services for People with Disabilities in the Community and Voluntary Sector Final Report.

The service will be regionally structured with five regional teams to provide a service to people with all types of disability across the country. Each regional team will be managed by a particular Citizens Information Service in Dublin, Westmeath, Offaly, Waterford and Leitrim. Teams will have a regional manager, a senior advocate and a number of other advocates. In the near future, the enactment of the instrument to legislate for the advocates statutory powers as set out in the above legislation will be agreed. The Managers in the different regions are as follows:

## Meeting Law Reform Commission

The Law Reform Commission has invited the National Federation of Voluntary Bodies to an informal discussion on the Review of the Criminal Sexual Offences Act, 1993, as part of their consultation on Sexual Offences and Vulnerable Adults Project under the Commissions Third Programme of Law Reform. Nominations will shortly be sought from member organisations for people to attend this meeting which is scheduled for Wednesday 30th March in the Law Reform Commission Offices. The meeting will be organised in two parts:

- (1) The first part will be for National Federation members to exchange views with each other and agree key messages.
- (2) The second part of the meeting will be with Patricia T. Rickard Clarke, Commissioner of the Law Reform Commission and Darelle O'Keefe, Legal Researcher on the project.

The LRC intend to publish a consultation document on this area in September 2011.

### **Training and Development**

### SKILL Programme 2011/12 – Call for nominations:

The National Federation of Voluntary Bodies has been allocated 150 places for the SKILL Programme training which is commencing in autumn 2011. To date almost 900 staff / managers from across National Federation member organisations



have registered with the SKILL Programme with 420 participants having successfully completed their training and graduated. Two briefing sessions, jointly organised with the Disability Federation of Ireland, took place during February 2011 and were targeted at training personnel and Support Service Staff / Managers.

Through the work of the group two FETAC Level 6 Standards (specific purpose certificates) for Manual Handling Instruction and People Handling Instruction have been developed. ### Vhi Corporate Solutions – Employee Assistance Programme (EAP):



The Vhi Corporate Solutions Employee Assistance Programme (EAP) provides confidential counselling and information services to 28 member organisations of the National Federation of Voluntary Bodies. The purpose of the EAP is to provide employees within member organisations with easy access to confidential short term counselling and to date, has provided support for a wide range of issues including both personal and work related concerns, which include emotional health, relationship, financial and family issues.

All employees in contact with the service receive a comprehensive psycho-social assessment according to their specific needs, followed by the identification of the most appropriate plan of action, whether that be a referral to a counsellor or other support/resource options that suit these needs. This immediate access to experienced and qualified EAP professionals – both qualified counsellors and information specialists - ensures that employees are provided with a positive and supportive first contact through which they can access the highest quality assistance and support on both work and non-work related issues.

### Case Study:

The two facets of the EAP team often work in tandem in the provision of support to an individual i.e. providing practical information in conjunction with emotional support. A recent case example of how this works is as follows:

An individual called through to the EAP regarding her husband's business which is failing. Their family home has been used for collateral and a lot of the loans were in her name. The EAP Specialist Information team provided information on how to approach banks and also information on who to go to for legal assistance with her current situation. During this the clinical team also provided emotional support and the person was referred out to face to face counselling to help deal with relationship issues and stress, which were caused by the situation she is facing.

The EAP is provided by Vhi Corporate Solutions and in conjunction with the NFVB, a highly competitive rate has been agreed for all member organisations. # Roscommon Advocacy Council / Research Group Project

The Roscommon Advocacy Council / Research Group consists of Suzanne Birchill, Mary Reddy, Stacey Myers, Margaret Conneran, Ruth Costello, Sean Keaveney & Tommy Hoey. The group is co-ordinated by the Kieran Keon & Anna Nolan (Social Work dept). The group has conducted a Research Project on Bullying. The methodology included one-to-one interviews and a focus group. This information has been collated into a final report. The findings of the



research have been presented at the National Advocacy Conference in Clare. They have also presented their work in Trinity College Dublin at the Anti-Bullying Strategy group and in Galway at the Inclusive Research Network gathering.

The Advocacy/Research group have also made a short video which involves a story entitled "I'd like to choose who I dance with" that tells the story of a young woman who experiences bullying on a night out. The video along with the research report portrays the message that Bullying is unacceptable and informs people what they should do to deal with this issue of Bullying such as; talking to friends, making a key person aware of the problem and also makes suggestions on how people should be supported to do role plays to educate each other on how to deal with some issues that affect them. The group have said that they have worked very hard in 2011 and hope to continue to work on researching issues that affect people with an Intellectual Disability and indeed the wider community.



### 'WORKING IN PARTNERSHIP' -

### ABILITY WEST SERVICE USER COUNCIL

Ability West has a Service User Council in place which is representative of service users throughout its services. The Council has 13 members and meets regularly with the main purpose of being a representative voice for service users and having a meaningful forum by which issues of common interest are discussed. Council members regularly meet with the Senior Management Team and other groups within the organisation. Jimmy Sweeney, Chairperson of the Council also meets regularly with Breda Crehan-Roche, Chief Executive of Ability West.

Members have been working through advocacy training which is good support when it comes to Council work. Ability West is currently developing its Strategic Plan for the next 3 years and the Service User Council have been involved in this. Indeed the Council have been instrumental in highlighting elements of crucial importance identified by service users themselves as part of this Plan.

We would like to link up with other Service User Councils throughout the country to form alliances in terms of sharing experiences, discussing common interest issues and being a mechanism for providing support to each other.

The Autism Europass Access Tool (AutismEPAT) has been developed by a multi-disciplinary team working across five EU countries (Germany, Ireland, the UK, the Czech Republic and Portugal).

The Autism Europass Access Tool (AutismEPAT) is intended to facilitate access to the Europass CV for people on the autism spectrum. Its function is to structure a conversation about any or all aspects of a person's life, with a view to building up a picture of that person's competencies and strengths, in the specific domains that can be included on a Europass CV. In this respect it is a 'scaffolding' device, aimed most specifically at those people on the autism spectrum who have difficulties communicating with others, and for whom potentially useful resources such as the Europass CV would traditionally remain inaccessible. As such it is designed to empower people with autism and to enhance their opportunities for fuller inclusion in all aspects of life.

- The tool is web-based, easily accessible, and free.
