Forecasting Demand for Future Disability Services

Ms. Grainne Collins, National Disability Authority, presented a report on the *Future Demand for Disability Services* at our General Assembly on 6th December, 2017.

The report was prepared by Working Group 1 of Transforming Lives, upon which the National Federation of Voluntary Bodies is represented by Brian O'Donnell and Christy Lynch.

The report is comprehensive in its reach and the findings make it quite clear that a substantial multiannual investment programme will be required to meet the forecasting need over the coming years.

A number of findings stand out:

- The number of residential ID places required in 2020 is likely to have increased by 400-500 over its 2015 level, and by 700-800 by 2025 due to demographic changes alone.
- About 15% of people with intellectual disabilities aged 60 or over are not in supported residential care. The current living arrangements for people of this age, on this scale, many of whom are being cared for by people who themselves are growing older, will not be sustainable in the long term. There is latent demand which will manifest itself in the not too distant future.
- The proportion of under-45's accessing residential supports has fallen by 10% approximately since 2007. This deferred demand has fed into rising numbers presenting for residential care as emergency placements. A return to the 2007 residential rates would add a further 1200 residential places required.

- The related capital costs to 2020 are likely to be in the region of €55-60m and to total €95-€100m by 2025.
- The main drivers of cost are the numbers of staff required to support individuals at any one time.
 Complex medical needs or severe behavioural difficulties will need constant attention and support, with a small number of people requiring two to one staff on a waking night basis to meet their needs.
- A baby boom in 2008-2010 period is generating increased demand for school-age services for children with disabilities, while demand for early intervention should fall in line with more recent falls in the birth rate. Research would indicate that demand for pre-school services will fall off by about 10% between 2015 while demand for school-age services will increase by about 11%.
- Demand for disability therapy specialists is likely to double in the period up to 2025. Our National Federation of Voluntary Bodies Working Group on Adult Therapies will soon finalise a report which will outline requirements in further detail.

While there are many caveats and different scenarios presented in the report, it leaves nobody in any doubt about the scale of the challenge facing the sector. Total annual disability spend will need to increase to €240m by 2020 and by the order of €325m-€390m by 2025.

As the umbrella group of voluntary Intellectual Disability service providers, we welcome this landmark report and the clarity it brings to the future needs of people we support and their families over the coming decade. Informed planning cannot take place without evidence and this report provides strong evidence of the future needs of people with ID over the coming years.

It is vitally important that the findings of this important report are brought to Government's attention as a matter of priority. The Transforming Lives Working Group are currently considering future actions.

As the year draws to a close may I take this opportunity to thank National Federation members for their engagement in the work and activities of the Federation throughout the year, and to wish you and your families a very happy and peaceful Christmas.

Policy update

New Working Group established which aims to address Health Inequalities for Older Adults with Intellectual Disabilities

As part of its service planning work for 2017, the National Federation examined the Healthy Ireland framework and ways its health outcomes can be considered for people with disabilities in the implementation of the framework. Following on from this reflection, one key area of urgency for action identified was the outcomes for older persons with Intellectual Disability. The National Federation engaged with the School of Psychology in the University of Limerick to take on a third year student, Evan Canny for a 6 month placement, and Evan led out on the preparation work for addressing this area.






Following on from the preparation work, which included a proposal that was approved by the Board of the National Federation, the Federation has established a working group to look at ways in which health inequalities for older adults with intellectual disabilities can be addressed. The first meeting of the group took place on 4 December 2017, in Trinity College Dublin. Attending were a range of National Federation members, together with Prof. Mary McCarron and Prof. Philip McCallion, who shared evidence of areas of need from the third wave report of the IDS-Tilda research, which had been launched earlier that day. Dr. Eimear McGlinchey also shared a research evaluation of a brain training programme that was used with adults with Down Syndrome, to contribute to preventative brain health in the context of the high prevalence of dementia in this group.

A range of National Federation members from across the country have indicated their wish to take part in the work. The Working Group now will develop Terms of Reference and examine initiatives to

improve health outcomes for older adults with intellectual disabilities that are achievable in the short and medium term.

Housing for people with disabilities – revised allocations guidance issued to Local Authorities



The Department of Housing, Planning and Local Government has issued to all Local Authorities, a revised and updated guidance document on the allocation of social housing for people with disabilities; "National Guidance for the Assessment and Allocation Process for Social Housing Provision for People with a Disability".

It is useful for members supporting people to access social housing options to be familiar with these Guidelines as they advocate with the Local Authority on behalf of people they support. Ms. Claire Feeney Senior Executive Officer with the Housing Agency attended the Next Steps meeting on 22 November 2017, and highlighted the options that are available to people with disabilities in accessing housing, along with the

plans of the local Housing and Disability Steering Groups, including the introduction of the *Offer Zone* in terms of housing from Local Authorities, and a 20% discretion that Local Authorities can apply for a person with a disability to the ceiling of payments under the Housing Assistance Payment (HAP). The revised allocation guidance also confirms the potential for flexibility in terms of options for an extra room for equipment or a support person when a person with a disability accesses social housing supports.

Nursing Supports for Children in Schools

A number of issues regarding governance and funding for nursing supports to children with complex medical needs attending school have been highlighted by Federation members over the past 2 years. A Working Group was established by the Department of Education in early 2017 to examine these issues. The National Federation made a submission to this Working Group outlining members' issues and a number of members made submissions in their own right. The Working Group considered submissions from all stakeholders and held a consultation day on 23 November 2017 at which the National Federation was represented by a number of member organisations and the Secretariat.

At the consultation the Department presented a draft plan which will now form a report to Government. Mr. Jim Mulkerrins, Department of Education, has indicated that he would welcome further consultation with members on the detail of the implementation if the draft plan submitted to Government is approved. We will continue to update members as this work proceeds.

Consultation on the Future of Home Care Services

The National Federation collated and submitted a paper to the Department of Health's consultation on the Future of Home Care Services, on 2 October 2017. The paper highlighted the significant importance that home care services play and will play in the future in the context of service provision being moved to community. It also highlighted the current and emerging need for support for family carers of people with disabilities, and for home care supports that are being provided to both a person with a disability and aging family carers to be carefully tailored and coordinated to meet the needs of both. A wide range of members provided input into the submission.



Next Steps Community of Practice and Learning

The Next Steps Community of Practice and Learning was delighted to welcome Minister Finian McGrath at its meeting on 14 September 2017. The meeting was a very positive opportunity to inform the Minister about the work of our members in developing individualised and innovative supports and our ongoing shared learning in this work. The Minister indicated that the group provided very useful information from the ground and that he would like to stay connected with the group and potentially attend again in the future.



On 13 October 2017 the Next Steps community filmed the second instalment of the Voice Box Video Booth, at the Brothers of Charity National Advocacy conference in Salthill. The topic for this film was 'What I want to say about.... Work' and 48 self-advocates came and shared their experiences of working, looking for work and what work means to them. Transcription of the intervews and editing is underway. A short version of the first film 'What I want to say about HIQA' has been completed, signed off by the Next Steps group and will be posted online shortly. A number of member organisations have recently joined the community, brining the number of members involved to 27. The next meeting will take place on 31 January 2017.

Conference Report

Inaugural Progressing Disabilities Services (PDS) conference in Limerick

On Friday 1st December 2017, Finian McGrath TD, Minister of State with Special Responsibility for Disabilities addressed the *Working to Support Children and Young People with a Disability and their Families* Conference, part of the HSE's *Progressing Disability Services for Children and Young People* programme.

Organised by the National Progressing Disability Services (PDS) for Children and Young People Working Group, comprised of HSE and children's disability service providers, the conference took place at Mary Immaculate College, Limerick. The conference brought together more than 300 parents and staff to share learning and good practice in the provision of disability services for children and young people, and was an opportunity to explore innovative ideas and celebrate achievements to date. A further 550+ delegates joined the conference via Webinar.



The Progressing Disability Services Conference Planning Group with Minister Finian McGrath

The main aim of the conference was to:

- Promote achievements of Children's Disability Network Teams in place as part of *National Progressing Disability Services for Children and Young People* Programme (PDS)
- Showcase/spread good work practices within Children's Disability Services

- Provide support for parents and staff of children's disability services who are currently planning their reconfiguration into Children's Disability Network Teams
- Promote HSE/Voluntary Organisations partnership working for optimal benefits of children and young people with a disability and their families
- Launch new PDS website www.hse.ie/childdisability

The delegates heard presentations from children's disability teams, schools, clinicians and parents and participated in plenary sessions and practical workshops. Diverse topics such as working with families, a parent's perspective, assessment for autism, parents' support groups and helping children to sleep better which demonstrated the concept of working in partnership and PDS in action were discussed.

The PDS programme acknowledges the scale of the change plan underway and the issues faced by children with a disability and their families across the country. While there are some very good services for children with a disability and their families there are also some large gaps. The basic tenet underpinning PDS is to find a fairer way to provide services for all children with disabilities, based on a child's needs rather than on their diagnosis and where they live. PDS is changing the way services are provided across the country to make it equitable and consistent for all.

Speaking at the conference Dr Cathal Morgan, HSE Head of Operations, Social Care Division said 'Up to now our services for children with disabilities, which are delivered by non-statutory organisations as well as the HSE, have varied throughout the country resulting in inequity of access and inconsistency. By reorganising staff into Children's Disability Network Teams for every area, the *Progressing Disability Services for Children and Young People* programme will mean every child will have access to services according to their needs.'

The conference programme incorporated a number of plenary sessions and breakout sessions as well as a keynote presentation by Kerry Intervention and Disability Services (KIDS) on 'Progressing Disability Services in Action'. This presentation by Julie O'Neill, Team Manager of KIDS Mid Kerry Network, Caroline O'Sullivan, Physiotherapy Manager KIDS South Kerry Network and Fionola Hogan, Senior Clinical Psychologist, KIDS Tralee Network gave a very honest account of the challenges and triumphs of the Kerry teams in working towards the Progressing Disability Services model. Honesty about the challenges whilst sharing learning and successes was the order of the day and this was evident also in the presentations by Anne Hughes-Kazibwe and Nicole Dryssen from Kildare West Wicklow and that of Anelle Marynowski and Anine Willemse from Meath.



A particular highlight was the moving and honest presentation by Silvia Segales-Angel, Early Intervention Specialist and mother of a child with Austism in 'Working with Families: from a Mother's Perspective'. Silvia had three core messages for clinicians working with families;

(1) Correctly identify family priorities. Silvia noted how very often professionals base their interventions with her son Sebastian on the results of tests and checklists that may or may not be relevant to her family at that point in time and asks that instead professionals should base their intervention on the unique difficulties that a family may be facing in their day to day life.

- (2) Develop parent's resourcefulness. Silvia asks that professionals consider how they can do themselves out of a job by teaching parents how to teach their child. She spoke very positively about a therapist who had worked closely with her husband in their home teaching him practical ways to develop their child's communication skills and how she sees her husband still utilising these skills to this day.
- (3) Give families actionable steps that are easy to implement. Silvia spoke of the lengthy and often overwhelming reports that are given to parents leaving them at sea as to where to begin to help their child. She asks that instead of 4-5 pages of goals clinicians break this down into smaller more achievable bite-size goals that can be incorporated into every day family life.



National Federation IT Sub Committee

The IT Sub Committee met most recently in October 18th at the Brothers of Charity Services in Limerick. A a wide range of agenda items were discussed including the use of Microsoft preparation for 365, the implementation of the General Data Regulations, Protection Cyber insurance, and the development of an IT Strategy. At each meeting during the year, a

presentation has been organised. For October meeting Independent Living Ireland was invited to attend. Patrick Mulvihill presented on the range of Assistive Technologies services that Indpendent Living Ireland are involved in providing and sourcing for the local and wider community, and how these have been supporting people with intellectual disabilities to maximise their independence. he IT Sub Committee agreed to maintain the structure of meetings going forward and will meet on four accasions in 2018.

General Data Protection Regulation

The General Data **Protection** Regulation (GDPR) will come into force on the 25th May 2018, replacing the existing data protection framework under the EU Data Protection Directive. The GDPR very significantly increases the obligations and responsibilities for organisations and businesses in how they collect, use and protect personal data. At the centre of the new law is the requirement for organisations and businesses to be fully transparent about how they are using and safeguarding personal data, and to be able to demonstrate accountability for their data processing activities. Protection Commissioner has set up a specific website <u>www.gdprandyou.ie</u> with information for individuals and organisations. It has a 12 step guide for preparing for the GDPR which may be useful for organisations.

The National Federation of Voluntary Bodies organised for a company, Sytorus, to assist our member organisations to be ready by hosting the following:

- An information session in April 2017;
- Data Protection training in May 2017;
- ➤ A 2 day Data Protection Officer Training in September 2017.

The GDPR has been widely flagged as an issue that will require substantial preparatory work by organisations in order to be ready for the May 2018 deadline. In this regard, we also invited Sytorus to present at a number of our National Federation Working Groups meetings, where they provided details on (a) Privacy Engine Tool and (b) a 2 Day Data Protection Officer Training.

In order to respond to enquiries from members in relation to the Data Protection Officer (DPO) Training, Sytorus will deliver a 2 day Data Protection Officer Training course which will take place in our offices in Oranmore, Galway on 29th & 30th January 2018. HR Updates

Social Care Workers Task Group

A Task Group has been established by the National Federation to consider the CORU registration process and other issues arising in relation to Social Care Workers, including:



- Consideration of College Programmes syllabus;
- Clarity of role of Social Care Workers;
- Progression Routes for Social Care Workers/Leaders.

'Using Social Media as a means of Recruiting Staff' Training:

Using social media to investigate a prospective employer is now commonplace for job seekers. Equally, organisations and HR professionals are increasingly turning to social media as a means of identifying talent. On November 7th last a 1-day training programme on the theme of 'Using Social Media as a means of Recruiting Staff' was organised by the National

Federation which sought to help employers in the voluntary sector get to grips with the intricacies of using social media in the recruitment process. The training, delivered by Mr. Gert Ackermann, The Wheel, focused in particular on:

- Understanding the social media landscape
- How job seekers use social media
- LinkedIn: company pages, talent search and LinkedIn for Non-profits
- > Twitter: hashtags, though-leaders and brand leadership
- Facebook: brand pages, representing your organisation's culture and targeting through Facebook advertising
- Social media management and metrics
- Mitigating risk: social media policies and procedures
- The future of social media and HR.

Further training in this area will take place in 2018.

Quality Updates

Code of Practice for Community Dwellings

Following the signing of the Code of Practice for Community Dwellings by Minister Eoghan Murphy, the Code is now available on the Dep. of Housing Planning Community and Local Government website:

The new Code of Practice will now form **The Design Brief for New and Existing Community Dwellings** going forward.

There is now a New Purpose Group of 1d that covers Community Dwellings in TGD B 2017 Fire Safety Volume 2 Dwellings Houses. The key factor in the new document is that Purpose Group 1d is exempt from the following:

- 1. Fire Safety Certificate
- 2. Disability Access Certificate.

The establishment of this Code of Practice means that new Community Dwellings can be developed from existing building stock within the Mainstream Housing Environment as per The National Housing Strategy.

Review of the National Safeguarding Policy:

Work on the review of the National Safeguarding Policy is progressing. The National Federation held a Workshop for Federation members in early September to discuss issues arising for Federation members in relation to the operation of the Policy and a formal submission was made to the Review Development Group at the end of September. It is expected that the revised Policy will be finalised in early 2018.

The Dept. of Health has recently announced the development of a national safeguarding Policy for the health sector. It is envisaged that the Policy will be underpinned with appropriate legislation and a public consultation and engagement process will be undertaken in 2018.

Tusla - Child & Family Agency

On October 23rd last a meeting took place between representatives of the National Federation and Tusla at which a range of child welfare and protection issues were discussed. The meeting was a very productive one and a number of actions will be followed up on in 2018.

Children First:

Key elements of the Children First Act came into effect on December 11th last and organisations will have 3 months to reach compliance – this includes provisions in relation to:

- Mandatory Reporting
- Mandatory Assisting &
- Development of Child Safeguarding Statements (CSS) in relevant services

A range of support documents have been developed by Tusla to support organisations:

- New Children First Guidance Document (to replace 2011 version)
- Child Safeguarding Document (to replace Our Duty to Care)
- Guidance on Reporting
- Protocol on Mandatory Assisting
- TUSLA eLearning module (similar to HSE, open to everyone, Certificate available on completion of eLearning module)
- Training standards that agencies can use to develop their own training programme

HSELand – Children First Training:

There is a requirement on agencies to ensure that the targeted 90% of staff / volunteers have completed the HSEland Children First online learning module by year end. Organisations can access the number of staff members who have completed the module so as they can track completion rates. The contents of the online Module are due to be updated to reflect the requirements of the Children First Act due to be commenced in mid-December 2017.





Funding News

€4.5m fund to support the reform of disability services

On 24 November 2017, Minister of State with special responsibility for Disabilities, Finian McGrath TD, announced a €4.5m fund to support the reform of disability services. The Minister said, "This Government's objective is to deliver disability services that are person—centred, putting those who need supports at the centre of all our activities. The objective of this fund is to put people with disabilities at the heart of service delivery and supports, enabling them to lead self-directed lives in the community."

The funding is part of the Service Reform Fund (SRF) which was established by the Department of Health, the Atlantic Philanthropies, the HSE and Genio to support the implementation of reforms in disability and mental health services in Ireland. The SRF represents a total combined investment of €45m by the Department and Atlantic to re-configure existing services towards more person-centred supports which are also more transparent, accountable and cost-effective, in line with government policy. Funding will be allocated under three streams:

- Community Living supporting people to move from congregated settings or institutions to
 the community; to have improved living arrangements in the community; and to lead selfdirected, meaningful lives, engaged in local and mainstream activity. This will be aimed at
 those who are moving from an institution or those at risk of institutionalisation.
- Reform of day services to person-centred supports supporting alternative ways of meeting the work, education, training and recreation needs of people with a disability within mainstream, community settings.
- 3. Alternative Respite developing a range of non-institutional respite options for individuals and their families.

Regional HSE representatives (i.e. Community Healthcare Organisations) will invite consortia – including people with disabilities, family members, service providers and community groups – to work together to develop proposals for funding. Consultations will take place over the coming months with service users, families and service providers across Ireland to develop realistic, sustainable plans to reconfigure services. Funding will be awarded by the Genio Trust through a rigorous application process jointly assessed by the Genio Trust and the HSE.

"HSE acknowledges the role of the Service Reform Fund as a key enabler in creating a more modern support service for people with disabilities. Embedding change in a partnership way with service users, families, community healthcare organisations and service providers will assist in ensuring a sustainable change model with the service user central to the process. HSE is aware of the challenges that change can present and is committed to engaging with all stakeholders to ensure the available resources are utilised to best effect", stated Mr Pat Healy, National Director of HSE Social Care. EUROPEAN STRUCTURAL FUNDS – PUBLICATION LAUNCHED

On 22nd November 2017, the initiative Community Living for Europe: Structural Funds Watch launched a Report in the European Parliament, Brussels co-hosted by Mairead McGuinness, MEP (EPP) and Vice President of the European Parliament and Iskra Mihaylova, MEP (ALDE) and Chair of the European Parliament Committee on Regional Development.

The initiative is based in the Centre for Disability Law & Policy, NUI Galway and financially supported by Lumos.

The report concerns the role of the European Structural and Investment Funds (ESIF) with respect to the transition from institutional to community-based living for children and young people, including those with disabilities, adults with disabilities and older persons in European Union Member States. It contains examples, both positive and negative, that demonstrate how the Member States have implemented the ESIF regulations, how they are currently using or are planning to use the ESIF to support the transition to community-based living, and provides concrete recommendations for the current and next funding period post 2020.

Delta Centre Carlow

Congratulations to Delta Centre in Carlow, for an award received in the 'Housing for People with Disability' category in the Irish Council for Social Housing Allinanz Community Housing Awards.

Delta and Tinteán Housing were delighted to receive this award, particularly since the residents were consulted from the beginning with the Architect and the design of the house arose from this collaborative work. The award category included independent living accommodation for people with intellectual, physical or sensory disabilities, and the housing 'Tinteán Willow' is the first group home for people with disabilities, designed and constructed to Passive House standards.

The ICSH award noted that the housing provided incorporates excellent standards of air tightness, thermal performance of the building fabric, photovoltaic panels and an air-to-water heat pump. Other sustainable measures include the use of a mechanical ventilation heat recovery system and rainwater harvesting on site. The low primary energy requirement of Tinteán Willow provides protection to the tenants and service provider against future price increases, while addressing the need for increased heating requirements, as many residents may have an inactive or sedentary lifestyle. In order to cater for tenants with different types of dementia, special requirements were taken into consideration at design stage with regard to awareness and orientation, safety and security and the provision of visual and acoustic stimulation.

The house is a good example of successful collaboration between Tinteán Housing and partners – Delta Centre, Carlow County Council, Department of Housing, Planning, Local Government, the HSE and HIQA. The judging panel highlighted the scheme as one that demonstrates a "landmark achievement by a Housing Association, delivering a top-class facility for the residents, ensuring their independence and specialised needs are met."



WALK

We are delighted that the WALKways Tallaght Hospital programme was announced as the joint winners of the Health Management Institute Leaders Award 2017. This programme is a partnership between Tallaght Hospital, WALK and the Dublin and Dunlaoighre Education and Training Board. This is an amazing outcome for all partners. It is fantastic to have this achievement recognised at a national level through this award.

This is a one year programme where job seekers with intellectual disabilities can gain relevant and meaningful work experience, be accredited for their practical learning and ultimately, move on to access paid employment in the open labour market. Each trainee will complete three by four month work rotations and will be able to choose from a number of roles across 11 hospital departments.
