It began with a reflection on the evolution of residential services by a number of speakers from the Brothers of Charity & Ms. Elks. It continued on the theme of what makes a home? Family & friends coming to visit etc. Why Home is so important to people at every stage of their lives.

The group reflections were on how group homes in residential services are not real homes but more like workplaces for staff who take over rooms for office space. The groups spoke of how in some group homes people are not able to go home until 3pm as houses are not open due to staff rosters. Others said how there was no intimacy or privacy. We spoke about what could be done to change this.
