Marsha Marshall is a Canadian import to New Zealand who describes herself as "on a crusade to promote self-direction and individualised approaches". Her career extends over 25 years in health and disability, in both New Zealand and Canada, with a focus on creating programmes that transfer control over supports back to the person receiving them. Marsha is passionate about this approach because she has seen the transformational effect this has on people's lives, in a variety of health and disability contexts.



Self-direction has been a part of all the roles Marsha has occupied in New Zealand, first at Starship Hospital setting up the Family Options programme, then at Waitemata District Health Board leading community and home care services, and then at the Ministry of Health where she led the team that expanded the Individualised Funding programme across New Zealand. Marsha continues this journey in her current role as the Chief Executive of Manawanui – New Zealand's largest Individualised Funding Host.

Dr. Wolfgang Plaute is Professor of Special Education and Inclusion at the University of Education in Salzburg, Austria. His professional career started more than 30 years ago in the field of special education, first working for a parent's organization called Lebenshilfe, where he was responsible for the housing programme in the Austrian state of Salzburg, before working for an organization in the German state of Bavaria. There he was responsible for research and the development of new inclusive services. Since 2013 he has been working at the University of Education in Salzburg and is the designated



vice rector for the education of teachers at primary and secondary level, both with a dedicated programme on inclusive education. Dr. Plaute is responsible for research and evaluation strands of the European project INVESTT. He will share information at the seminar on the INVESTT Project, which focuses on inclusive vocational training in Austria, Belgium, Norway and Slovenia. The educational approach is directly connected to the principles of universal design.
